Sample Design Packaging Agreement

This Design Packaging Agreement (the "Agreement") is made and entered into this [Date] by and between [Designer Name] ("Designer") and [Client Name] ("Client").

1. Scope of the Project

The scope of the project (the "Project") is to design packaging for Client's product, [Product Name]. The packaging shall include the following:

- A box
- A label
- A hang tag

2. Deliverables

Designer shall deliver the following deliverables to Client:

- A PDF of the packaging design
- A physical prototype of the packaging

3. Timeline

The Project shall be completed within [Number] days of the date of this Agreement.

4. Budget

The total budget for the Project is [Amount].

5. Payment Terms

Client shall pay Designer in installments as follows:

- 50% upon signing of this Agreement
- 25% upon delivery of the PDF of the packaging design

8. Entire Agreement

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, understandings, and negotiations, whether written or oral.

9. Amendment

This Agreement may be amended only by a written instrument executed by both parties.

10. Counterparts

This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

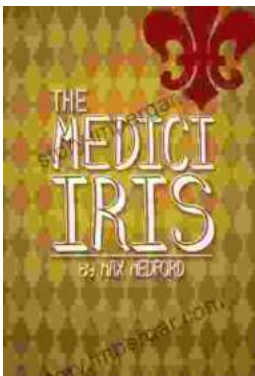

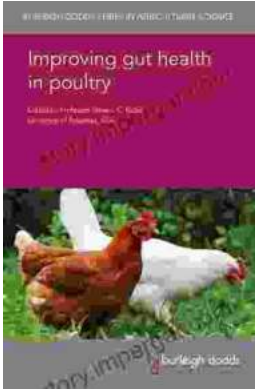
