IDENTIFICATION OF PARTIES: This agreement, is made between _____

LEGAL SERVICES TO BE PROVIDED: The legal services to be provided by Attorney to Client are as follows:

RESPONSIBILITIES OF ATTORNEY AND CLIENTS: Attorney will perform the legal services called for under this agreement, keep Client informed of progress and developments, and respond promptly to Client's inquiries and communications. Client will be faithful and cooperative with Attorney, keep Attorney reasonably informed of developments, and of Client's address, telephone numbers and whereabouts, and timely make any payments required by this agreement.

COMPENSATION: Client will pay Attorney for the legal services provided under this agreement as follows:

Hourly Compensation: In consideration for the services to be performed by Attorney, Client agrees to pay to Attorney at the following rate:
- \$0.00 per hour for legal services.

Attorney will charge an increment of one tenth of an hour, rounded off for each particular activity to the nearest one tenth of an hour. The minimum time charged for any particular activity will be one tenth of an hour.

Attorney will charge for all services (including, but not limited to, the following: conferences, court sessions, and depositions, preparation and participation in testimony and legal documents review and preparation, legal research, and telephone consultations). When two or more of Attorney's personnel are engaged in working on the matter at the same time, such as in conferences between them, the time of each will be charged to Client at the hourly rate.

Payment is required for all services and expenses upon receipt of any invoice.

If, while this agreement is in effect, Attorney becomes the hourly law firm of a client, generally, the provisions of this agreement shall apply to the client's legal services.

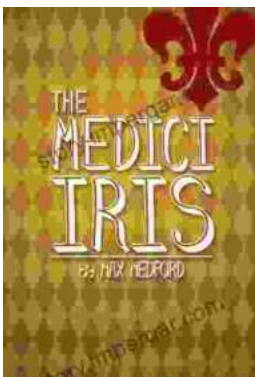

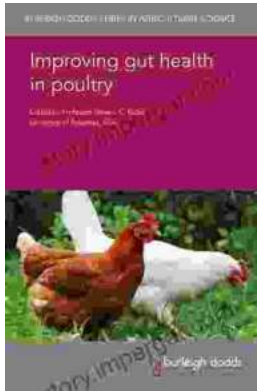
